A quorum must be established at an in-person location open to the public, and members attending remotely may exercise voting rights only if an in-person quorum is met. Any Council member seeking to participate remotely must submit written notice to the President, Recording Secretary, and Administrative Assistant no later than 24 hours or upon immediate acknowledgment of said emergency before the scheduled meeting to ensure compliance with quorum requirements
